### Detailed Notice Inviting Expression of Interest

**Notice Inviting Expression of Interest (EOI) for “Setting up of Water Carrier System for utilization of required quantity/up to 5 MLD of RO Treated water for one or more industrial consumers”.**

**Keenness money for participating in this Expression of Interest Rs. 2.00 lakhs (Rs. Two Lakhs Only) in the form of Demand Draft drawn in favor of BLMCL payable at Jaipur.**

Barmer Lignite Mining Co. Ltd. (BLMCL) is a joint venture Company between Rajasthan State Mines and Minerals Ltd (RSMML) and JSW Energy (Barmer) Limited (JSWEL), with RSMML holding 51% equity. BLMCL holds the mining leases for the Kapurdi and Jalipa Lignite deposits. Both these deposits are located in the district of Barmer in Rajasthan and have gross reserves of 450 million tonnes (approx). The individual mineable reserve of Kapurdi lignite mine is around 129 million tonnes and individual mineable reserve of Jalipa is around 310 million tonnes. These mines are captive source of fuel to the 8 x 135 MW Thermal Power Plant established by JSW Energy (Barmer) Limited (JSWEL) at village Bhadresh Dist. Barmer Rajasthan.

While mining lignite at Kapurdi & Jalipa mines, Barmer, BLMCL has encountered a huge aquifer under pressure at a depth of ~~Approx~~ - 90 m, capable of producing considerable amount of brackish water. Out of this, BLMCL intends to supply approximately 5 MLD RO Treated water to the companies willing to pay facilitation fees to BLMCL in lieu of the infrastructure, tube-well development, etc. Presently, BLMCL is collecting abstracted water in an idle pit within mine lease. The interested companies who are prepared to build their own Water Carrier System for consumption of RO Treated water for captive use will be required to draw water from this idle pit. Besides developing the Water Carrier System, the bidders are required to:

1. Construct a suitable water reservoir for strong raw water pumped from pit/tube-wells. A water carrier system to their project site will be connected with this reservoir for onward transmission to the work sites. Bidders will also be required to construct their own tube-wells at an earmarked location to take care of the eventuality when BLMCL's pumps are under shifting or not in operation and water availability in idle pit drops.
2. Maintain the pipelines, en-route pumping stations, booster pumps (as required) etc. for smooth and efficient functioning of the water carrier system.
3. Acquire land or obtain surface rights for the Water Carrier System, if required.
4. Take necessary steps for obtaining all statutory approvals/permissions from various State and Central Government Agencies.
5. Obtain their own power connection for operating their Water Carrier System, 33KV/11 KV HT power lines is available at the mine site, which may be used if approved by DISCOM/RVSNL.
6. The successful bidders are required to pay facilitation fees on per cubic meter basis for the contracted quantity, whether or not they are able to draw the contracted quantity from the defined date.

## Section – I

### 1.1.1 Background & Brief details of project

Barmer Lignite Mining Co. Ltd. (BLMCL) is a Joint Venture Company between Rajasthan State Mines and Minerals Ltd (RSMML) and JSW Energy (Barmer) Limited (JSWEL), with RSMML holding 51% equity. BLMCL holds the mining leases for the Kapurdi and Jalipa Lignite deposits. Both these deposits are located in the district of Barmer in Rajasthan and have gross reserves of 450 million tonnes (approx.). The individual mineable reserve of Kapurdi lignite mine is around 129 million tonnes and individual mineable reserve of Jalipa is around 310 million tonnes. These mines are captive source of fuel to the 8 x 135 MW Thermal Power Plant established by JSW Energy (Barmer) Limited (JSWEL, a subsidiary company of JSW Energy Limited) at village Bhadresh Dist. Barmer Rajasthan.

From the mining operations the approx. 20-25 MLD water is being extracted from the mines and being fed to our 15 MLD and 3 MLD RO plants situated in the Kapurdi – Jalipa Lignite Mines. BLMCL is expecting rise in water release from further mining operations and hence this tender is floated for water sale to the desired.

### 1.1.2 Location & Accessibility

RO plant located at Kapurdi and Jalipa mines.

#### **Kapurdi Lignite Mine**

The mining area falls in village Kapurdi of Barmer District. It is approx. 25 Km. North from Barmer town. The site can be approached from N.H. 15

The nearest railway station is Barmer which is approx. 25Km. away from Kapurdi.

The area falls under the Survey of India Top sheet no. 40-0/5, within Latitude 25°56': 25°58' and Longitude 71°21'22": 71°22'20".

#### **Jalipa Lignite Mine**

Jalipa Lignite block is situated 15 km north of Barmer town on National highway-15 in the district of Barmer.

The nearest railway station is Barmer which is approx.15 Km. away from Jalipa. The area falls in the Survey of India Topo sheet No.40-0/5(Plate-II) and is limited by latitude 25°51' 15" to 25°55' 46" and longitude 71°20' 26" 71° 24' 51".



### 1.1.3 Climate

The area falls in the arid region with scanty rainfall. Minimum 330 days are available for actual working in the mining areas.

### 1.2 Purpose of RO (treated water) Sale

BLMCL is expecting rise in water release from further mining operations. Hence, BLMCL intends to invite proposal from competent bidder for sale of RO (treated water) (treated water) from Kapurdi – Jalipa Lignite Mines from its 15MLD / 3MLD RO Plant. Further, and hence this tender is floated for water sale to the desired.

BLMCL intends to supply this RO (treated water) to the company willing to pay facilitation fee to BLMCL. The facilitation fee is in lieu of drawing. RO (treated water) discharged by BLMCL in its 15 MLD /3MLD RO Plant of Kapurdi – Jalipa Lignite Mine. BLMCL will grant permission for build its own water carrier system for consumption minimum 1 million litres per day (MLD) RO (treated water) for captive use.





## SECTION-II

### DEFINITIONS AND DECLARATION BY THE BIDDER

- 2.1 **Definitions:** - In the Agreement (as hereinafter defined) the following words and expression shall have the meaning hereby assigned to them, except where the context otherwise requires.
- 2.1.1 "Accredited representative of Bidder" means a person duly authorized by the bidder to receive information and instructions from the company for the project.
- 2.1.2 "Agreement" shall mean the long-term supply Agreement signed between the BLMCL and the selected bidder for sale of RO (treated water).
- 2.1.3 "Approved" shall mean approved in writing by the Company/or any other officer so designated by the Company
- 2.1.4 "Appointing Authority" shall mean the Managing Director of the company.
- 2.1.5 "Area of Kapurdi – Jalipa Lignite Mine Lease" shall mean the area bound by the lease boundary of lignite mines at Kapurdi – Jalipa Lignite Mines.
- 2.1.6 "Bidder" shall mean an entity, whose bid has been received by the company and shall include his/its/their legal representatives, administrations, successors and executors.
- 2.1.7 "Board" or "Board of Directors" shall mean the board of directors of the Joint Venture Company as nominated or appointed in accordance with the terms & conditions of this bid document.
- 2.1.8 "Companies Act" shall mean the companies act, 1956 as amended from time to time or replaced by the similar legislation & shall include the rules & regulations made there-under.
- 2.1.9 "Detailed Letter of Acceptance (DLOA)" shall mean intimation by BLMCL vide letter /e-mail/ fax to bidder that their bid has been accepted.
- 2.1.10 "Facilitation fee" shall mean an amount payable to BLMCL by bidder on per cubic meter RO (treated water) discharged 15 MLD/3MLD RO Plant from the Kapurdi – Jalipa Lignite Mine.





- 2.1.11 "First year of commercial operation" shall mean, the period starting from the date of completion of gestation period after issuance of DLOA.
- 2.1.12 "Gestation period" shall mean 06 months period from the date of issuance of DLOA.
- 2.1.13 "Managing Director" shall mean the Managing Director of Barmer Lignite Mining Company Limited or his successor in office.
- 2.1.14 "Mines" shall mean Kapurdi – Jalipa Lignite Mine.
- 2.1.15 "Mines Manager" shall mean the person appointed under Mines Regulation, 1957 for Kapurdi – Jalipa Lignite Mine.
- 2.1.16 "Nodal Officer" shall mean the officer of the Company specifically authorized for enforcing the agreement on behalf of the Company
- 2.1.17 "Project" shall mean Lignite Project, Barmer in district Barmer.
- 2.1.18 "Successful Bidder" shall mean the bidder declared successful as a result of the bidding process and with whom the Agreement is signed for supply of RO Water.
- 2.1.19 "RO water" shall mean water generated 15MLD/3MLD RO Plant at Kapurdi – Jalipa Lignite Mines and having TDS of 500-1000ppm.
- 2.1.20. "Water supply" duration will be 24 hours a day.
- 2.1.21. "Calendar month"- 1st of every month to end date of every month. This will be treated as a reference for billing purposes.

## SECTION-III

### SCOPE OF RO (TREATED WATER) SALE

#### 3.1 Scope

Following will be the scope of contract:

- (1). BLMCL offers minimum 1 MLD OR multiply of 1MLD afterwards, Maximum 5 MLD RO treated water for captive use for duration of 5 years.
- (2). The bidder shall be provided a tapping of point on the existing outlet header pipe of 15MLD/3MLD RO plant switched at Kapurdi & Jalipa Lignite Mines Barmer, Rajasthan.
- (3). The bidder shall maintain the pipe lines, en-route pumping stations, booster pumps (as required) etc. at his own cost for smooth and efficient functioning of the water carrier system. The route of pipe line within mine lease area will be approved by BLMCL for laying of suitable diameter of usable pipe line.
- (4). The bidder shall acquire land or obtain surface rights for the water carrier system, if required for laying of the pipelines M/S. BLMCL will provide the land free of cost for pipe laying from wherever it is connected adjacent to the plant premises.
- (5). The bidder shall take necessary steps for obtaining all statutory approvals/permission from various State and Central Government agencies.
- (6) The successful bidder is required to pay facilitation fees on per cubic-meter basis of the contracted quantity, whether or not he is able to draw the contracted quantity.
- (7). The bidder will be required to install flow meter(s) near the point of water drawing for be responsibility of the bidder
- (8) The responsibility of BLMCL to provide RO (treated water) will end with the expiry of mine lease/surrender of mine lease/depletion of RO (treated water) incidental to mining operations.

#### 3.2 Period of the Contract

The period of the contract shall be five (05) years from the date of issue of LOA/ DLOA. This period may be extended for further 5 (Five) years till the or incaution of water whichever is earlier at the sole discretion of BLMCL.

4.1.2 The bid along with covering letter and information to be included in the bid shall be submitted along with the offer itself as hereunder.



4.1.3 Bid should be submitted in two parts viz. Part I and Part-II in separate double sealed envelopes duly super scribing for "Sale of RO (treated water)(treated water) from Kapurdi – Jalipa Lignite Mines of BLMCL in district Barmer of Rajasthan" with bid number, the due date and time of opening, the time and date of submission of bid, full name, postal address, telegraphic address, fax number, E-mail ID of the bidder(s) shall be written on the bottom left hand corner of each of the sealed envelopes by bidder duly identifying the bid. Further, envelopes containing each part shall be super scribed as under:

Part I -"Techno Commercial offer"

Part II -"Financial offer"

Then both the separates shall be put together in another sealed Envelope super scribing Bid Name and Number as detailed above.

## **4.2 Part I - "Techno Commercial offer"**

4.2.1 The bidder shall submit the following documents with techno commercial offer:

4.2.2 Letter of submission of bid as per Form 'A'

4.2.3 Details of the bidder in Form 'B'. Proof of status of bidder Company by way of Memorandum & Article of association/ Registered Partnership deed etc. duly attested by the gazetted officer/ notary public.

4.2.4 A declaration that price bid is in the prescribed format and no conditions are mentioned along with it as per Form-'C'.

4.2.5 Exceptions & Deviations as per bid conditions in Form 'U. Exception and deviations made elsewhere in the offer shall be ignored. However, it will be desirable that deviations are avoided as far as possible and rate offer be made based upon terms & conditions of RFP.

4.2.6 Power of Attorney in favour of the authorised representative signing the bid as per Form "E".

4.2.7 Details of the project/ approach to be followed for establishment of water carrier system flow diagram with size of pumps motors etc. PERT chart of various activities to be completed in stipulated time frame.



4.2.8 Complete set of bid document (Original Copy) as issued and duly filled in and signed with company seal on each page by the bidder as in token of acceptance of terms and conditions of this bid.

### **4.3 Part II -"Financial Offer"**

4.3.1 the bidder is required to quote rates for facilitation fee in Rupees in the Financial offer (Part-II), in separate sealed envelope, duly super scribing financial offer for "Sale of RO (treated water) from Kapurdi – Jalipa Lignite Mines of BLMCL, District: Barmer (Rajasthan)" strictly in the format at **Form - F on the letter head of the Bidder.**

4.3.2 The bidder should quote rate in English both in figures as well as in words in such a way that insertion and/or interpolation is not possible. In case of difference in the amounts quoted in "words" & "figures", the higher of the two shall be taken as the quoted amount.

4.3.3 The facilitation fee to be quoted for the bidding strictly in the format at Form—F on the letter head of the Bidder.

4.3.4 The facilitation fee is to be quoted on per cubic meter RO (treated water) strictly in the format at Form - F on the letter head of the Bidder. The service tax or any other tax, cess, etc. payable on date or levied in future by whatsoever name called, shall be charged extra by BLMCL on actual basis.

4.3.5 The Environmental & Water cess, etc. applicable on per cubic meter of RO (treated water) discharged to be paid by the bidder other than the facilitation fee.

### **4.4 Exception and Deviation**

4.4.1 Bidder is advised to submit quotation based on the terms & conditions and specifications contained in the bid document and not to stipulate any deviations. Should it become necessary to take any exception and/ or deviation then those should be given in Form —D only. No exception and deviation or any condition should be mentioned in price bid or any other place except in prescribed Performa i.e., in Form-D in the tender.

4.4.2 The exceptions & deviations, if maintained by the bidder and, if in the opinion of the company, can be evaluated after loading financial component on the price offered by the bidder; the same may be evaluated at the sole discretion of the Company. An exception or deviation if not acceptable to the Company or cannot



be converted into financial loading then it may result into rejection of the offer.

#### **4.5 All pages to be initialled**

**4.5.1** All signatures in bid documents shall be dated as well as stamped. The pages of all sections of bid document shall be initialled at the lower right-hand corner and signed wherever required in the bid papers by the bidder or by a person holding power of attorney authorising him to sign on behalf of bidder before submission of the bid

**4.5.2** The bid shall contain the name, and place of business of bidder & other details as per Form-B

#### **4.6 Validity**

**4.6.1** Bid submitted by bidder shall remain valid for acceptance for a period of 120 days, from the date of opening of Techno Commercial Offer (Part-I) The bidder shall not, during the period of 120 days revoke, cancel and/or withdraw his bid nor shall he make any variation therein. In case of bidder revoking, cancelling and/ or withdrawing his bid or suo-moto varying any term in respect thereof, the keenness money deposited by him along with Bid shall stand forfeited.

**4.6.2** In exceptional circumstances, prior to expiry of the original time limit, the company may request the bidder to extend period of validity for a specified additional period. The request and the bidder's response shall be made in writing. The bidder if agreeing to the request will not be permitted to modify his bid.

#### **4.7 Addenda/Corrigenda**

**4.7.1** Addenda/corrigenda to the bid documents may be issued to clarify documents or to reflect modifications in the design / drawing, specifications. Agreement terms etc.

**4.7.2** Addenda/ corrigenda to these bid documents, if issued by the company, shall form an integral part of this bid document and must be signed and submitted along with the bid documents.

#### **4.8 Security Deposit**

**4.8.1** The successful bidder shall furnish a Security Deposit equivalent to **one year** facilitation fee for minimum guaranteed annual payment within 21 days from the date of issuance of LOA/DLOA by





BLMCL. The amount of SD is to be deposited through Demand Draft / by way of Bank Guarantee

- 4.8.2 The Bank Guarantee shall be provided only in the approved format of the company from a PSU(except SBI)/ICICI/Axis/HDFC Bank having its branch at Barmer/Jaipur on non-judicial stamp paper of 0.25% of BG amount subject to maximum of Rs.25000/- or appropriate value at the time of issuing the BG.
- 4.8.3 The bidder may initially provide the BG valid for a period of one year along with claim period of six months from the last date of validity of the BG. The bidder would need to renew the BG every year for one year so as to ensure that valid BG is available with BLMCL for the period of Agreement plus six months claim period. The bidder shall renew the BG in advance at least one month before date of expiry of BG as furnished to BLMCL.
- 4.8.4 The Security Deposit shall be liable to be forfeited wholly or partly at the sole discretion of the Company, should the bidder either fail to fulfil the obligations or fail to settle in full, his dues to the Company or non-signing of the agreement within stipulated period.
- 4.8.5 The Company may deduct from the Security Deposit any sum due and any other sum that may be fixed up by the Company as being the amount of loss or losses or damages suffered by it due to delay in performance and/ or non-performance and/ or partial performance of any of the terms of the Agreement.
- 4.8.6 In case the Bank Guarantee is invoked for any reason/s, the bidder is required to furnish a fresh Bank Guarantee in the same format for the same amount and for the same period as the original Bank Guarantee within a period of 30 days from the date of invoking of original Bank Guarantee.
- 4.8.7 In the event of security amount at any time during the currency of the Agreement falling short of the specified amount, the bidder shall forth with make good the deficit on demand, so that the total amounts of Security Deposit will not at any time be less than the amount so specified
